



Sherburne County Board of Commissioners June 26, 2018 - County Board Meeting Minutes

The Sherburne County Board of Commissioners met in regular session on June 26, 2018, at the Sherburne County Government Center in the City of Elk River, MN with all Commissioners present. Call to order by the Chair was at 9:00am followed by a moment of silence and the Pledge of Allegiance to the Flag.

It should be noted that the County may repurchase the land for the exact same price within one year if the lands are not placed back on the tax rolls. 
