On October 1, Robert Wilts on County Road 14 NW in Big Lake Township reported the theft of items from his property. Items taken included: a Stihl BR 600 leaf blower, a Stihl FS 110 weed whip, an extra weed whip blade, a Ryobi 26cc gas pruner, a Port-a-Power 10-ton hydraulic ram, a Hobart handler wire feed welder, a Hobart plasma cutter, 2 small sets of ratchet wrenches, and a Makita handheld angle grinder. Estimated value of the items taken is \$3,098.00.

On October 12, Devon Block on 100th Street NW in Livonia Township reported the theft of a 1972 Suzuki dirt bike. The bike is red and silver in color with black handles and seat with a grey gas tank. Value of the bike is estimated at \$3,000.00.
