Another ballot based on voter intent was counted as blank or undervote by the machine, but the voter made the mark outside of</p>

		<p>the required area for the machine to read. So in the hand count it was determined by voter intent for that candidate. That equated to a 0.0541% difference which was in the acceptable range. The equipment performed well as expected in the 2018 General Election based on the final PER Review report for Sherburne County for the November 6<sup>th</sup>, 2018 General Election.</p>
