## Visitation Rules

**Failure to abide by the rules stated below may result in loss of visitation privileges for an inmate and/or visitor, as determined by Jail Administration.**

**All visits are monitored and recorded.**

### On-Site Visitation Rules

- All visitors 14 years of age and over, must present a valid government issued photo I.D. such as driver's license, State I.D. card, military I.D., school I.D. etc.
- No persons under the age of seventeen (17) can visit without a parent or legal guardian. Children must be supervised and kept under control at all times.
- All additional friends/family visiting with you must be listed when you schedule the visit, or they will not be allowed to visit.
- No purses, bags, firearms or weapons of any type, cell phones, video or audio recording devices, or cameras will be allowed in the facility. All personal effects must be left at home or in your vehicle.
- Visitors must wear conservative clothing. Shirts must have sleeves. No halter tops, swim suits, tank tops, strapless tops, see-through or provocative clothing, or any shirt that exposes the midriff. Shorts more than 6" above the knee, mini dresses and miniskirts are prohibited.
- Nudity, partial nudity, sexual acts, simulated sexual acts, or depiction thereof is prohibited.
- Inappropriate, suggestive or lewd behavior, on or off camera is prohibited.
- Taking pictures/videos of an inmate during a visit is not allowed.
- It is recommended that visitors arrive 5 minutes in advance in order to check in. Visits start precisely at the scheduled time and cannot be rescheduled for the same day if late or missed.

- Jail Staff may refuse a visit if a visitor appears under the influence of any intoxicating substance, refuses to cooperate, fails to produce identification or acts in a disorderly manner.
- Visitors may not wander through or loiter in the visitation area. Visitors must **stay seated** at their assigned booth during visitation.
- No eating, drinking, or use of any tobacco or nicotine products/devices while in the video visitation area.
- All visitors are required to follow the instructions of staff. Visitors failing to cooperate, or disrespecting staff, will be asked to leave, terminating the visit, and are subject to the revocation of visiting privileges.

### **Remote Visitation Rules**

- The registered user of the account must be present, on camera, during all visits scheduled under their account. Other friends/family may join you as long as they are physically present, abiding by all visiting rules, and you are also actively participating in the visit.
- Staff must be able to verify the registered visitors' identity during the visit by visual comparison of the visitor and the visitor's submitted photo(s). Inability to verify a visitors' identity, will result in termination of the visit.
- An additional device(s) may not be used to enable another person(s) to participate in your scheduled visit.
- Driving during a remote visit is not allowed. If you are driving, your visit will be cancelled.
- Performing any activity that would be deemed dangerous, inappropriate or a violation of the law is strictly prohibited.
- All visitors, including children, must be, and remain, fully clothed at all times. Wearing just undergarments, to include lingerie, will not be considered full clothed.
- Nudity, partial nudity, sexual acts, simulated sexual acts, suggestive or lewd behavior, on or off camera, is prohibited.
- Displaying (or using any reflective surface or other device) which enables an inmate to view nudity, partial nudity, sexual acts, simulated sexual acts, suggestive or lewd behavior, on or off camera, is prohibited.
- If you have the need to breast feed during a visit; please remain covered.
- Utilizing other devices/videos/audio recordings, either on or off camera, to display nude, inappropriate, suggestive or lewd images is prohibited.

- Taking pictures/videos of an inmate during a video visit is not allowed. If any photos, videos, etc. of the inmate/inside of the facility are found displayed on social media, the visitor's visiting privileges will be suspended for a length of time as determined by Jail Administration.
- You, and the inmate you are visiting, are prohibited from using abusive or inappropriate language, being disruptive, yelling and/or using profanity.
